# III. Website Updates & Feedback

Members discussed latest updates for the myCGS Web Portal.

 Members reported the new Medicare Beneficiary Identifier (MBI) converter tool was helpful to their staff who utilize the Interactive Voice Response System (IVR). Angie explained the importance of completing MAC Customer Experience (MCE) surveys and the difference between the surveys and the feedback tab. CGS is improving the appearance of the MCE surveys on the website. Sarah asked members for ideas on how to increase MCE participation. Members indicated they will encourage their staff to take surveys.

### IV. POE Educational Activities

Sarah led discussions on the following activities:

- CGS will hold two mega workshops: one in Columbus, Ohio on November 1, 2023, and the other in Charlotte, NC, on November 11, 2023.
