I. Welcome & Introductions

Sarah welcomed the group to the meeting, reviewed the primary function of the group, and reminded members to complete the survey (located on the website).

II. News & Updates

Sarah provided the following updates:

- The DMEPOS enrollment contractor, National Supplier Clearinghouse (NSC), is changing. Effective November 7, 2022, two new contractors will process DMEPOS applications: NPE East: Novitas Solutions and NPE West: Palmetto GBA. Sarah displayed the slide that is being used to educate suppliers during webinars. Attendees were asked for feedback and suggestions.
- Suggestions from the previous JC POE AG meeting were discussed. The following suggestions were implemented:
 - The Dear Physician Letter for High Frequency Chest Wall Oscillation Devices was published on the CGS website (https://www.cgsmedicare.com/jc/mr/doc_req.html).
 - ii. Education regarding the COVID-19 Public Health Emergency was provided during the August 25, 2022, A/B MAC Glucose Monitor webinar.
- Sarah shared the newest versions of the myCGS Web Portal.
 Attendees were asked for feedback and suggestions on the
 newest updated version and if any additional education was
 needed. Members were pleased with the usage of the myCGS
 same and similar option, notating that the search is displaying
 consistent results.

III. Website Updates & Feedback

- · Members discussed CGS's search engine.
- Frequently Asked Questions (FAQs): Sarah and Angie announced that CGS is currently revamping the FAQs.

Currently, the FAQs are in one section. CGS will divide the FAQs into two sections. There will be the FAQs section and a separate section for POE Questions and Answers (Q&A). The POE Q&As will not be frequent questions but will rather include questions that we receive from a variety of resources such as webinars, the call center, workshops, etc.

IV. POE Educational Activities

- Members inquired if CGS has an additional resource for items
 that require span dates when billing other than a published
 article and the Standard Documentation Requirements for All
 Claims Submitted to DME MACs. Sarah showed the group
 where to locate the "Claim Span Dates & Claim Narrative
 Charts" on the CGS website (https://www.cgsmedicare.com/pdf/dme/dme_claims_span_date_narratives.pdf). Attendees
 provided feedback that this chart is useful as it provides the
 exact HCPCS codes that require date spans when billing.
- Members expressed the CGS Disaster Page was very helpful.
 A member suggested that CGS either adds the counties affected by disasters or a link to the FEMA website to access a list of affected counties.
